Lunch & Learn

Bullying will be the focus of the April monthly “Lunch and Learn” program sponsored by the Lincoln/Lancaster County League of Women Voters. Senator Gwen Howard and Bob Moyer, Executive Director of the Family Violence Council, will be the speakers.

Senator Gwen Howard has introduced LB 205 which requires schools to adopt a policy on bullying. She will explain how this legislation came about and why this legislation is necessary.

Bob Moyer, with Lincoln Public Schools and Swanson Russell Associates, created an ad campaign that targets bullying. This ad campaign entitled “Practice Positive” tries to hit at the underbelly of bullying by

making parents think about what they are teaching their children and how their actions influence their children.

The April “Lunch and Learn” will be held Thursday, April 19th, at noon at the Nebraska Club – top of the U.S. Bank on 13th and “M” Streets. Everyone is welcome. Candidate Debates on April 10

The debates will be taped and re-broadcast several times before the election. The public is welcome to attend. Audience members are asked to refrain from wearing or otherwise displaying items indicating support of specific candidates while in the debate area.

1:00-2:00 pm, LPS District 2 Doug Evans has declined the nomination, but Richard Meginnis will be present to discuss school issues informally with interested voters. Informal discussions are NOT taped and re-broadcast.

2:15-3:15 pm, City Council District 4 (Annette McRoy and John Spatz)

3:30-4:30 pm, City Council District 2 (Jon Camp and Allan Abbott)

4:45-5:45 pm, City Council District 3 (John Erickson and Jonathan Cook)

6:00-7:00 pm, City Council District 1 (Doug Emery and LaRae Eifert)

7:30-8:30 pm, Mayoral debate (Chris Beutler and Ken Svoboda)

Airport Authority candidates have been invited to be present throughout the afternoon and evening in the area reserved for campaign materials distribution.

To reach the Bevins Family Life Center from the west doors, use the elevator (“M” button). If entering the church through the south door, go up the interior stairs and walk away from the sanctuary. Parking is available across 11th Street or in the parking garage one block south of the church. On-street parking or free space in the garage under the church (enter from 11th Street) may also be available.
